SUBJECT: Joint Base Myer-Henderson Hall (JBM-HH) Policy Memorandum ES-9, Arming of Military Police (MP), Department of the Army Civilian Police (DACP), Department of the Army Security Guards (DASG) and Augmentees (Non-MP)

1. REFERENCES.

2. PURPOSE. To provide specific guidance concerning the arming of MP, DACP, DASG and augmentees (non-MP) performing law enforcement, access control, and security duties on Joint Base Myer-Henderson Hall (JBM-HH), Fort McNair, Arlington National Cemetery, Soldier Airmen National Cemetery and Air Force Memorial, which will be referred to as the JBM-HH community throughout the remainder of this memorandum.

3. APPLICABILITY. This policy memorandum applies to all MP, DACP, DASG and augmentees (non-MP) assigned OPCON or TACON to JBM-HH Directorate of Emergency Services (DES)/Provost Marshal (PM) as mentioned above.

SUBJECT: Joint Base Myer-Henderson Hall (JBM-HH) Policy Memorandum ES-9, Arming of Military Police (MP), Department of the Army Civilian Police (DACP), Department of the Army Security Guards (DASG) and Augmentees (Non-MP)

4. POLICY.

a. The Joint Base Commander will determine the arming status of MP, DACP, DASG and augmentees performing law enforcement, access control and security duties by balancing their evaluation of the threat to the installation with the inherent risks associated with increasing arming status. The following factors will be considered when changing the arming status:

(1) Current law enforcement threat information (on post and surrounding off-post areas).

(2) High profile/recurring special events (particularly if they involve open house-type public access to installation property).

(3) Historic/current crime trends (timing, frequency, levels of violence, etc.).

(4) Current training/skill proficiency programs.

b. The DES/PM will provide subject matter expertise, recommendations and supervision of the execution of installation law enforcement, access control and security operations to the Joint Base Commander. The DES/PM will ensure comprehension of and adherence to this policy by all DACP, MPs, DASG and augmentees when operationally controlled during their performance of law enforcement and/or security duties.

c. MP/DACP performing law enforcement duties will carry their assigned pistol (M9 or M11), loaded magazine inserted with round chambered (weapons status RED).

d. DASG manning access control points (ACPs) will carry their assigned weapon (M9 or M11), loaded magazine inserted, with round chambered (weapons status RED).

e. Augmentees will be used at higher FPCONs to fortify ACPs, search areas, Mission Essential Vulnerable Areas (MEVAs) and perimeter guards. Types of weapon at each location will be dictated IAW MDW FPCON Uniform Matrix (Enclosure 1), and weapons status will be the same as DASG, or as directed by the Joint Base Commander or his representative (DES/PM).

f. When assigned, MP/DACP performing law enforcement duties will carry their assigned rifle (M4 or M16), unloaded in their patrol vehicle trunk rifle rack or weapon storage container. The ammunition will be stored inside ammunition container located inside of vehicle or on their person.

g. All personnel must qualify semiannually with their assigned weapon and will receive a use-of-force briefing quarterly (training will be documented).

5. PROCEDURES.

a. Definitions:

(1) Military Police/Department of the Army Civilian Police (MP/DACP): Trained law enforcement personnel, MP or DACP, performing law enforcement duties on the installation.

(2) Department of the Army Security Guards (DASG): Individuals responsible for access control and searches of all vehicular and pedestrian entry points into JBM-HH. In addition serves as a reactionary force to threats on JBM-HH.

(3) Augmentee: Non-law enforcement military personnel assigned from either internal or external organizations, performing security and guard force duties on the installation. Augmentees are not authorized to perform law enforcement duties.

(4) Arming Status: Brevity code description of the weapon and ammunition conditions:

(a) GREEN. Weapon issued. Rounds/magazines are issued to individuals but not inserted/loaded into weapons (i.e., stored in ammo pouch)

(b) AMBER. Rounds/magazines inserted/loaded into weapon. Ammo not loaded into chamber of weapon (requires deliberation action to place weapon into ready-to-fire configuration).

(c) RED. Ammunition loaded into chamber with weapon safety engaged. Weapon is in ready-to-fire configuration.

b. Oncoming and off-going personnel procedures:

(1) Oncoming and off-going DACP (and DASG upon assumption of duties) will utilize the clearing barrel behind the DES. The shift supervisor will supervise the loading and holstering for oncoming, and unloading and clearing for off-going, for all DACPs and DASGs. Investigators and the Traffic Section will supervise within their sections when assuming duties and leaving for the day.

(2) Oncoming and off-going MPs will utilize the clearing barrel adjacent to their company area (Bldg 417). The patrol supervisor is responsible for proper loading and unloading procedures IAW their company policy.

(3) Supervisors must remain vigilant when operating at weapons status RED and follow proper loading and unloading procedures IAW Army Regulations and Technical Manuals.

(4) Accidental/negligent discharges will be reported immediately to the Chief of Police, DES/PM and 289th MP CO chain-of-command (if applicable).
